BYLAW 8.2025

A BYLAW TO AMEND BYLAW 14.2023 KNOWN AS A BYLAW CONCERNING THE ERECTION OF HIGHWAY TRAFFIC SIGNS WITHIN THE RM

THE COUNCIL OF THE RURAL MUNICIPALITY OF ROSTHERN NO. 403 IN THE PROVINCE OF SASKATCHEWAN, ENACTS AS FOLLOWS:

- 1. Bylaw No. 14.2023 is amended as hereinafter set forth.
- 2. That Section 4 be amended as follows:
 - 4. “Speed Zone” means any portion of a highway within the following locations, as designated herein, and identified by a sign erected and maintained at each end thereof, indicating the maximum speed applicable thereto;
