BYLAW 8.2024

A BYLAW TO PROVIDE FOR ENTERING INTO AGREEMENT WITH THE Village of Laird respecting the joint funding of certain recreation facilities;

The Council of the Rural Municipality of Rosthern No. 403 in the Province of Saskatchewan enacts as follows:

- 1. The Rural Municipality of Rosthern No. 403 is hereby authorized to enter into Agreements attached hereto and forming part of this bylaw, and identified as Exhibit "A" with the VILLAGE OF LAIRD.
- 2. The Reeve and Administrator for the Rural Municipality of Rosthern No. 403 are hereby authorized to sign and execute the attached agreements identified as Exhibit "A".

VILLAGE OF LAIRD

THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. The parties to this agreement agree to provide the financial contributions in the amounts further provided in this agreement towards the cost of operation of the skating and curling rink also further mentioned in this agreement.
- 2. The parties to this agreement agree that the amounts referred to in Section One (1) shall be as follows:
 - a. The Rural Municipality of Rosthern No. 403 shall contribute a grant of 'Three Thousand and Eighty Dollars (\$3,080.00) per anum.
 - b. 'The Village of Laird shall contribute a grant of Four Hundred Eighty-Five Dollars (\$485.00)
- 3. The parties at the top of this agreement agree that the amounts payable by the Rural Municipality of Rosthern No. 403 shall be paid to the Village of Laird on or before the Thirty First (31st) day of December each year.
- 4. The Village of Laird hereby agrees to provide to the Rural Municipality of Rosthern No, 403 such documentation and accounting necessary to substantiate the amounts of monies expended upon the recreational facility mentioned within this agreement, such documentation to be provided on or before the Thirtieth (30th) day of April in the year following the expenditures of such funds.
- 5. The Rural Municipality of Rosthern No.403 and the Village of Laird agree that the skating and curling rink mentioned in this agreement will be available for all residents of each Municipality on an equal opportunity basis.
- 6. It is understood and agreed that this agreement shall apply for the year 2024 and shall continue in force for the years 2025 and 2026, but the agreement may be terminated by either party to the agreement by giving Sixty (60) days written notice.
